Votre commission a procédé le 21 novembre 2012 à l'examen de demandes de naturalisation et a émis un avis favorable sur 1897 d'entre elles.

A. Naturalisations accordées en application de la loi du 13 avril 1995 modifiant la procédure de naturalisation et le Code de la nationalité belge.

La commission propose d'accorder la naturalisation à 1 pétitionnaire dont le nom figure dans l'article 2.

B. Naturalisations accordées en application de la loi du 1 mars 2000 modifiant certaines dispositions relatives à la nationalité belge.

La commission propose d'accorder la naturalisation à 27 pétitionnaires dont les noms figurent dans l'article 2.

C. Naturalisations accordées en application de la loi du 27 décembre 2006 portant des dispositions diverses et modifiant le Code de la nationalité belge.

La commission propose:

a) d'accorder, en vertu de l'article 19, dernier alinéa, du Code de la nationalité belge, la naturalisation à 5 pétitionnaires dont les noms figurent dans l'article 2;

b) d'accorder la naturalisation à 1864 pétitionnaires dont les noms figurent dans l'article 3.

Dans certains cas, la commission a cru devoir, soit faire procéder à une enquête complémentaire, soit procéder elle-même à un examen approfondi du dossier après avoir pris connaissance des avis des autorités consultées. Dans chacune de ces affaires, vos rapporteurs ont conclu que l'octroi de la naturalisation pouvait être proposé à la Chambre.

La commission propose le rejet des dossiers qui portent les numéros suivants:

DAMES EN HEREN,

Uw commissie onderzocht op 21 november 2012 een aantal naturalisatieaanvragen en bracht in 1897 gevallen een gunstig advies uit.

A. Naturalisaties toegekend bij toepassing van de wet van 13 april 1995 tot wijziging van de naturalisatieprocedure en van het Wetboek van de Belgische nationaliteit.

De commissie stelt voor de naturalisatie te verlenen aan 1 aanvrager, wiens naam voorkomt in artikel 2.

B. Naturalisaties toegekend bij toepassing van de wet van 1 maart 2000 tot wijziging van een aantal bepalingen betreffende de Belgische nationaliteit.

De commissie stelt voor de naturalisatie te verlenen aan 27 aanvragers, wier namen voorkomen in artikel 2.

C. Naturalisaties toegekend bij toepassing van de wet van 27 december 2006 houdende diverse bepalingen tot wijziging van het Wetboek van de Belgische nationaliteit.

De commissie stelt voor:

a) de naturalisatie te verlenen overeenkomstig artikel 19, laatste lid, van het Wetboek van de Belgische nationaliteit, aan 5 aanvragers, wier namen voorkomen in artikel 2;

b) de naturalisatie te verlenen aan 1864 aanvragers, wier namen voorkomen in artikel 3.
